DISCOUNTS: For each additional child in the same family, a discount will be given each month. From the base monthly tuition, the second child's tuition will be discounted \$10.00; the third child's \$20.00.

TUITION PAYMENTS: The tuition is paid over an **eleven month period** on the first of each month **July through May**. Pre-payments may also be made annually or by semester. Your **July tuition payment** secures your child's class placement for the coming school year and is **non-refundable** should you choose to withdraw. Tuition payments are due the first of each month. A \$15.00 late charge will be added for accounts not paid by the 10th of the month.

Students who enroll after September will pay tuition on a monthly basis. July tuition will be recouped. After the school year has started, a pro-rated scale will be used to determine the cost of the initial month of entrance; however, for the months of August and December, full payments will be due. No refunds will be made for the month in which a student withdraws from school. Should there be a withdrawal from MRCA prior to the opening of school, tuition payments will not be reimbursed.

MEMBERSHIP STATUS: Mitchell Road Presbyterian Church membership status will be reviewed on July 1 and January 1 of each school year. If a family has completed all requirements to obtain MRPC membership status by July 1 they will receive the church member discount tuition beginning with the July payment. Another review will take place on January 1. All families having attained membership status between July 2 and December 31 will receive the church member discount in tuition beginning in January.

FINANCIAL ASSISTANCE: Family Financial Needs Assessment (FFNA) applications, which are available in the Business Office, should be **submitted by May 1 to FFNA**. MRCA uses FFNA to assess the family's financial needs for the school year. Students must be enrolled for consideration.

AFTER SCHOOL CARE: CASA (Children's After School Activities) is Mitchell Road Christian Academy's program for those parents who desire care for their child after the dismissal of classes. **This program does not offer drop-in care, but offers care by registration and pre-arrangement of days and hours.** The program operates until 2:00 p.m. for children in K3 and until 3:25 p.m. or 5:30 p.m. for children K-4 and up on all days that school is in session (including days with early dismissal). The program does not operate on snow days or school holidays. Please see additional sheets for policies, fees and procedures.
