Tuition Payments

MRCA uses FACTS for tuition payment processing and offers the following payment plans through FACTS:

- **Plan A:** Payment in FULL by August 1st (1% discount)
- **Plan B:** 50% Payment due by August 1st Remaining payment due by January 1st.
- **Plan C:** 11-Month payment plan. Those opting for this payment plan will be charged a \$55 service fee by FACTS at the beginning of every year this plan is chosen.

Discounts

Families with multiple children enrolled will receive monthly tuition discounts for each additional child.

*The Mitchell Road Presbyterian Church (MRPC) member discount will begin the month following the completion of all requirements necessary for MRPC membership.

A family may receive a maximum of three discounts, even if they qualify for more.

Financial Assistance

MRCA will require—and verify—that families who meet the eligibility requirements have first applied to the SC Education Scholarship Trust Fund (SC ESTF) program before any financial aid decisions are made through the FACTS Grant & Aid Assessment for the 2026–2027 school year. FACTS Grant & Aid Assessment is an online financial aid application that evaluates a family's financial need for the school year. Existing MRCA families should submit their application to FACTS by March 6, 2026. New families may apply for financial aid after submitting their admissions application to MRCA. Please note that because financial aid funds are limited, late filing (after March 6, 2026) of applications and supporting documentation may result in not receiving financial aid assistance. Financial aid awards are not considered final until all tax returns and W-2s have been received and verified by FACTS.
