Sound Beginnings, LLC is happy to partner with Mitchell Road Christian Academy to provide speech-language/hearing screenings and SLP services this school year. **Screenings are scheduled for the weeks of August 22nd and August 29th. Please return the attached forms by Thursday, August 18th.**

A screening is a pass-fail measure that indicates whether or not further assessment is warranted. Screening includes language (use and understanding), fluency, voice, articulation (pronunciation) and social-pragmatic skills.

The cost for screening is \$15 per child or \$20 per family (up to 3 children; \$10 per child over 3 children). Please fill out a separate form for each child in your family.

If an area of concern is noted, a full speech-language evaluation may be recommended to pinpoint areas of need and determine if therapy is warranted. If a hearing concern is noted, information about audiology services will be provided.

Speech-language services are available at school during the school day, on a private, contract basis. If your child is receiving services elsewhere, and you would like to transition to MRCA, please email Christa at admin@soundbeginningssc.net.
